With reference to Central Govt. letter No.U.12012/18/2014-ME(P-II) pt. dated 26.06.2014 forwarding therewith compliance of your medical college on the subject noted above, I am directed to state that the matter with regard to renewal of permission for admission of 2nd Batch of MBBS students against the increased intake from 100 to 150 at Chhattisgarh Institute of Medical Sciences (CIMS), Bilaspur under the Chhattisgarh Ayush & Health Sciences University, Raipur, Chhattisgarh for the year 2014-15 was considered by the Executive Committee of this Council at its meeting held on 08.07.2014 and it was decided as under: -

"The Executive Committee of the Council considered the letter dt.23.06.2014 received from the Dean, Chhattisgarlı Institute of Medical Sciences (CIMS), Bilaspur furnishing the compliance report for rectification of deficiencies pointed out by the Council Assessors in the assessment report as forwarded by the Central Government vide letter dated 26th June, 2014 received in the Council Office on 27th June, 2014 alongwith the previous assessment report (9th and 10th May, 2014) and noted the following:

- Deficiency of Residents still remains at 64.77 % (i.e. 57 out of 188)
- 2. Deficiency of Central Library remains as it is.
- 3. Deficiency of OPD registration counters remains as it is.
- OPD attendance is still inadequate as it is 920 against requirement of 1,000.
- 5. Deficiency of MRD remains as it is.
- 6. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee decided to convey the deficiencies still persisting after submission of compliance to the Institution/State authorities.
