8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute..."

I am directed to refer to MCI's letter No. MCI-37(I)(RI-22)/2015-Med./108911 dated 14.05.2016 on the subject mentioned above and to convey the approval of the Central Government for renewal of permission for admission of 4th Batch of MBBS students against increased intake i.e. from 100-150 for the academic year 2016-17 at Chhattisgarh Institute of Madical Sciences, Bilaspur under Chhattisgarh Ayush & Health Sciences University.

- 2. The permission is valid for one year and for admitting only one batch of students against increased intake i.e. from 100-150 during the academic session 2016-17. The next batch of students in MBBS course against increased intake will be admitted in the college only after permission of Central Government for renewal/recognition.
- 3. The Government Medical Colleges (except those located in J&K, Andhra Pradesh & Telangana States) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.
- 4. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made thereunder.
- 5. Discrepancies, if any, may be immediately brought to the notice of MCI and the Contral/State Government.
